## **Facts about a LIGONIER VALLEY YMCA THREE MONTH MEMBERSHIP:**

- All three month memberships must be paid in full at the time of application.
- The YMCA will accept cash, a personal check or MasterCard, Visa or Discover as methods of payment.
- A 3-month application form must be completed.
- The 3-month membership will run for three consecutive months from the date of purchase. (Example: purchased on March 3<sup>rd</sup> runs through June 3<sup>rd</sup>.)
- A membership card will be issued at the time of application.
- Three-month members must present their cards at the front desk upon entering the YMCA.  
**NO CARD= NO ENTRY**
- Membership privileges for a three-month member are exactly the same as they would be for an annual or monthly bank draft member.
- Three-month members may only register for those programs and activities, at the current member rate, which take place during the course of their membership period.
- Three-month members may continue to purchase additional three-month memberships year around, once their present membership expires.
- There is no grace period for three-month members. Once the membership expires, the membership privileges also expire.
- Lost or stolen membership cards should be reported to the YMCA front desk.
- Membership cards are non-transferable. Those found guilty of lending out their card to non-members shall have their membership suspended.
- Three-month members may upgrade their membership to an annual membership at any time during the three-month membership period. The amount of the three-month membership will be applied towards the cost of a new full year membership. The difference must be paid in full at the time of the upgrade. We will accept cash, MasterCard, Visa, Discover or a check. The expiration date will be the one year from the start of the original three-month membership.
- If a three-month member decides to continue the membership beyond the three months, with the membership fee being a monthly bank draft, the new membership-processing fee will be waived. The membership will not have an expiration date and the bank draft and membership will continue until the member notifies the membership office of any change.
- If a member has been a three-month member for 12 consecutive months and wishes to become an annual member or monthly bank draft member, the member would pay the renewal rate rather than the new member rate. (Any less than 12 consecutive months would result in paying the new member rate, unless the member opts to have a monthly bank draft.
- The YMCA Board of Directors has the authority to discontinue this type of membership and /or adjust the dues or regulations each year, as they deem necessary.
